 - (2) 1 unit of three-storey reinforced concrete building (Building B), for use as residential condominium (14 units), having an area/length of 4,824.94 square meters inclusive of car park, U-turn and access for 46 vehicles having an area of - square meter;
 - (3) 1 unit of three-storey reinforced concrete building (Building C), for use as residential condominium (18 units), having an area/length of 1,300.10 square meters inclusive of car park, U-turn and access for - vehicles having an area of - square meter;
 - (4) 1 unit of six-storey reinforced concrete building (Building D), for use as residential condominium (64 units), having an area/length of 5,406.49 square meters inclusive of car park, U-turn and access for - vehicles having an area of - square meter;
 - (5) 1 unit of eight-storey reinforced concrete building (Building E), for use as residential condominium (66 units), having an area/length of 4,689.96 square meters inclusive of car park, U-turn and access for - vehicles having an area of - square meter;
 - (6) 1 unit of eight-storey reinforced concrete building (Building F), for use as residential condominium (67 units), having an area/length of 4,643.01 square meters inclusive of car park, U-turn and access for - vehicles having an area of - square meter;
 - (7) 1 unit of eight-storey reinforced concrete building (Building G), for use as residential condominium (160 units), having an area/length of 9,256.85 square meters inclusive of car park, U-turn and access for 6 vehicles having an area of - square meter;
 - (8) 1 unit of three-storey reinforced concrete building (Building H), for use as car park, having an area/length of 2,213.69 square meters inclusive of car park, U-turn and access for 71 vehicles having an area of - square meter;
 - (9) 1 unit of outdoor reinforced concrete ground, for use as car park, having an area/length of 4,781 square meters inclusive of car park, U-turn and access for 78 vehicles, having an area of - square meter;



- (10) 1 unit of swimming pool, for use as swimming pool, having an area/length of 25.1 square meters inclusive of car park, U-turn and access for - vehicles having an area of - square meter;
- (11) 1 set of drainpipe, for use as drainage, having an area/length of 8,862 meters inclusive of car park, U-turn and access for - vehicles having an area of - square meter;
- (12) 2 sets of retaining wall, for use as retaining wall, having an area/length of 638 meters inclusive of car park, U-turn and access for - vehicles having an area of - square meter;

4. The Licensee must comply with the following conditions:
 - (1) The Licensee must comply with the principle, process and condition stipulated in the Ministerial Regulations or other local ordinances issued under Section 8 (11), Section 9 or 10 of the Building Control Act B.E. 2522.
 - (2) The Licensee must also obtain permission under other relevant laws concerning the abovesaid building.
